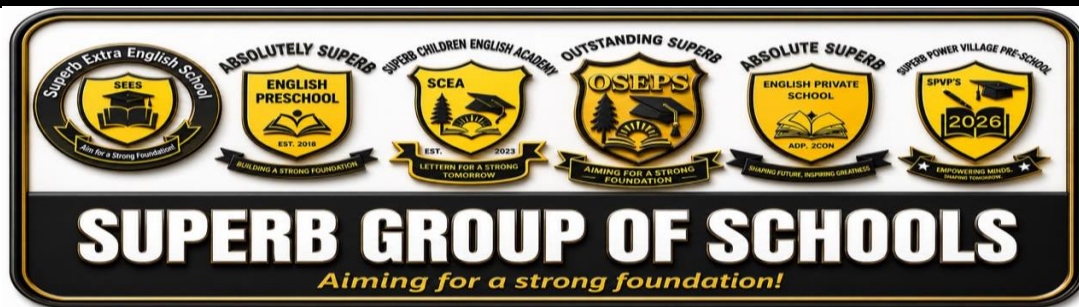

Please note that;

1. During the pandemic, school fees must be paid. Therefore, parents are expected to pay the full school and hostel fees due during that period.
2. Parents are expected to settle their child's school and hostel fees for 12 months before the child receives the school progress report.
3. All fees are payable in advance and are due on or before the 7th of each month. Late payments will attract a late payment fee of N\$100.00. For 2027, January fees are due on the 7th of January 2027
4. December fees are due on the 3rd of December.
5. No refunds of anything paid.
6. If you fail to pay school fees, the school will take you to a debt collection agency.
7. Every learner is expected to have full school uniform at the beginning of the year. No child will be allowed to attend classes without full uniform.
8. If you fail to settle monthly fees until the end of the academic year, you will be requested to pay double of your outstanding fees before or upon the collection of your child's report, and chances of your child not being readmitted are high.
9. Parents are not permitted to come visit learners without the hostel matron's permission; therefore, they must communicate with the hostel matron in advance.
10. A learner or parent is not permitted to bring any food not listed. Parents are advised to strictly adhere to the given list.
